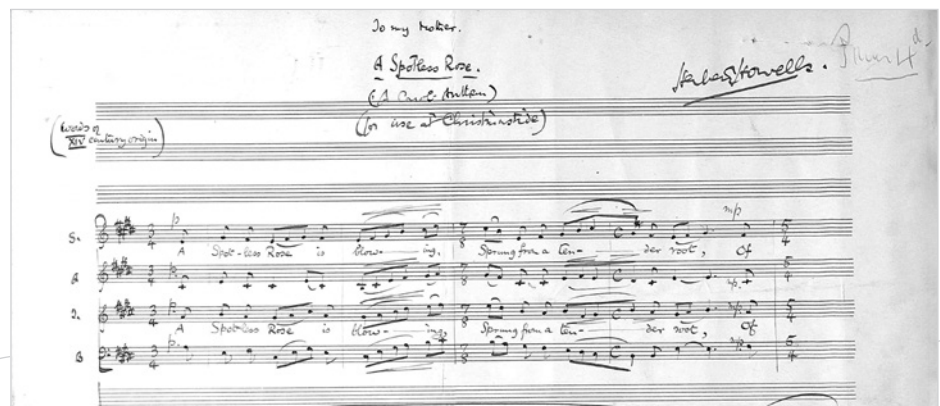

Nurturing world-class musicians is an intricate, meticulous, and extended process. It entails a lifelong commitment, as each student requires personalised attention and guidance. While tuition fees and the government's Higher Education funding cover some fundamental aspects of our work, the assistance of our generous supporters is vital to help us sustain the delivery of world-class education and provide life-changing opportunities.

Over the years, the RCM has thrived on numerous legacy gifts pledged by supporters in their Wills. Legacy gifts have enabled us to achieve what might not otherwise have been possible: to provide state-of-the-art facilities and performance spaces; undertake research; fund performances, creative projects, and fellowships; provide career support; and facilitate many more enriching musical activities for the benefit of our students as well as the wider public. Valuable legacies have also reached us in the form of fine instruments, portraits and sculpture, and collections of manuscripts. A quarter of the fine instruments in our collection loaned out to students have been gifted in Wills to the RCM.

Legacies provide us with the confidence to plan ambitiously. Gifts in Wills have contributed over a third of the £42.5 million More Music Campaign, which has recently transformed our campus, including a new performance hall, a new performance studio, a large café and courtyard area, and a new interactive Museum. The new Cotes-Burgan Atrium and several other teaching and practice rooms have been named after generous legators.

An increasing number of students are facing challenges in meeting the expenses associated with their education, including both tuition fees and the costs of daily living. More than a third of our talented scholars are studying at the RCM thanks to legacy gifts. Over £1 million is awarded every year in scholarships by donors who left gifts in their Wills or named a scholarship in memory of a loved one. Legacies for endowed scholarships, awarded in perpetuity, offer generations of exceptionally talented students the chance to fulfil their potential through study at the RCM, regardless of their financial means.

WHAT SORT OF GIFT COULD I LEAVE IN MY WILL?

Gifts towards RCM's general purposes (**unrestricted gifts**) allow us to make the most of your generosity according to the area of greatest need at the time, as our plans develop and priority changes.

Restricted gifts are used only for the purpose specified, for example scholarships or an area of our work. If you have a specific area in mind that you would like to support, we invite you to contact us and write a Letter of Wishes to accompany your Will (form enclosed at the end of the brochure).

THERE ARE THREE MAIN TYPES OF LEGACY GIFTS:

A **residuary gift**, whether it encompasses a percentage of your estate or its entirety, holds immense value for the RCM. Such a generous contribution can make a lasting impact for the future of music. A cash gift, also referred to as a **pecuniary legacy**, involves leaving a specific and fixed monetary amount in your Will, which can be used to support various initiatives at the College.

Many of our esteemed alumni and friends generously support by leaving specific assets to the RCM (**specific legacy**). These contributions can range from donating fine stringed instruments, valuable manuscripts, properties, royalties, or shares.

WHERE SHOULD I START?

To begin, it is advisable to employ the services of a solicitor who can assist you in preparing your Will, help you assess the overall value of your estate and document your wishes effectively. This straightforward procedure ensures that your intentions are legally upheld, and your loved ones, friends, and others are appropriately provided for in accordance with your wishes.

MAKING OR UPDATING YOUR WILL

If you have already made a Will, it is simple to update it with your solicitor or with your Will writing provider. You will also find a Pledge Form at the end of this brochure and a template for a Letter of Wishes (for a restricted gift), which you can use to notify us of your intentions.

Having a Will is crucial, especially to prevent complications that may arise for your family and friends in the event of your passing without a Will (intestate). If you have not created your Will yet, it is simpler and more affordable than you might expect. You are also welcome to make use of our free Wills service.

TAX MATTERS

Donations made to charitable organisations are deducted from your estate before calculating taxes, and they are entirely exempt from taxation. Consequently, leaving a gift to a charity, such as the RCM, can potentially reduce your Inheritance Tax Liability.

'I am so grateful to be studying at the RCM, supported by the Robert McFadzean Whyte Award established by a generous legacy gift. It is difficult to put into words the impact this year has had on my development as an artist. The course has allowed me to truly develop and hone my technical skill, artistry, and stagecraft. The opportunities I have been gifted have allowed me to put these skills into action in a safe and supportive environment before heading out into a professional career.'

At the time of printing, the Inheritance Tax threshold stands at £325,000. Estates valued above this threshold are subject to a 40% tax on the amount exceeding it. However, since the 2012 budget, if you make gifts to charities amounting to 10% or more of your estate, the Inheritance Tax rate can be reduced to 36%. This allows individuals to leave a significant and transformative gift to their preferred charity while reducing the net cost for their loved ones. It is important to note that everyone's tax situation is unique, so it is advisable to consult with a solicitor or independent tax adviser for personalised advice. DEED OF VARIATION

If you happen to be named as a beneficiary in a Will, it is possible to transfer a portion or all your inheritance to the Royal College of Music through a Deed of Variation. Not only is this a wonderful way to leave a gift in memory of a loved one, but also by utilising this method, gifts that are redirected to a charity become exempt from the Inheritance Tax. This can serve as an effective and meaningful way to support the RCM during your lifetime.
