Job overview	This role provides a 12 month training placement for a sound engineer with a strong interest in classical music, who wishes to develop high level skills in a wide range of operational disciplines including classical recording, editing and production, engineering film scoring sessions, mixing/directing live multi-camera video productions and running the live web streaming of classical concerts. This placement would be ideally suited to a student wishing to undertake a placement year as part of their studies.

Key Responsibilities

Main duties

- Assist the RCM Recording Engineers and Videographer with all technical operations in the studios and other facilities as required
- Engineer or assist with audio operations for studio sessions, live concert recordings, live streams and live performances
- Act as producer on student sessions when required
- Undertake editing, mastering and quality control for completed recordings in accordance with RCM delivery standards and ensure safe delivery to clients and/or the recording archives
- Work on single and multi-camera video productions, including post-production using Final Cut Pro and other systems
- Provide technical support for networked music events using advanced videoconferencing technology to connect to remote locations around the world
- Assist and advise academic staff and students on the use of technical equipment and software, including Pro Tools, Logic, Cubase, iMovie, MaxMSP, Q-Lab etc.
- Assist with basic administrative and other tasks to support the successful operation of the studios
